As an inducement to the owner of the property and to the agent to accept this application. I warrant that all statements above set forth are true; however, should any statement made above be a misrepresentation or not a true statement of facts, all of the deposit will be retained to offset the agent's cost, time, and effort in processing my application.

- 1. When so approved and accepted, I agree to execute a Contract to Lease within 7 days of acceptance. A Lease Preparation Fee \$45 will be collected at this time stating all agreed to terms of the forthcoming lease.
- 2. A Partial Security Deposit (If rent is under \$1300 Deposit is \$500 If rent is over \$1300 Deposit is \$1000) to remove the property from the market made payable to the landlord is due and payable at the signing of the Contract to Lease in a money order or certified check.
- 3. I agree to pay the balance of the Security Deposit prior to the move in date.
- 4. Next, an Attorney prepared Lease will then be provided for your review and signature.
- 5. Possession will be given after the lease is fully executed, when all monies due are collected on behalf of the landlord and all verifications are received.
- 6. If the application is not approved or accepted by the owner or agent, I hereby waive any claim for damages by reason of non-acceptance which the owner or agent may reject.
- 7. I understand I am responsible for securing utility services for this property if I am approved for tenancy.
